### Tribal Sponsorship Program

**(This is a Reimbursement Program)**

#### APPLICATION

The Tribal Sponsorship Program is offered to aid Tribal members in accessing reimbursement funding to address the following needs; Emergency Preparedness and Energy Generation, Health and Fitness, Healthy Foods, and Technology. Applicants will need to provide copies of receipts with the application verifying the purchase you will be requesting reimbursement for. This program is a limited duration program and will end once the funding has been exhausted. Applications will be process in the order a completed application is received.

If you owe a debt from any of the COVID-19 programs offered in 2021 you are **NOT** eligible to apply.

**Reimbursable Categories** (household is defined as one per physical address)

- Emergency Preparedness and Energy Generation - \$300 **per household**, CTGR member applicant must be 18 or older.
- Healthy Foods - \$300 **per household**, CTGR member applicant must be 18 or older.
- Health and Fitness - \$300 **per CTGR member** (list each CTGR member below)
- Technology - is a **one time** allowance. If you have received previously received the technology funding you are **NOT** eligible to receive it again. - \$500 CTGR Elder, \$500 CTGR member student, \$200 CTGR member non elder and non student.

The following documents **must** be included with a completed application to be considered for funding:

- \_\_\_\_\_ CTGR Tribal Enrollment Verification for all Tribal members listed on the application.
- \_\_\_\_\_ Completed Application. **Incomplete applications will be returned.**
- \_\_\_\_\_ Copies of Receipts clearly showing items and amount for each category that you are requesting reimbursement.

## POLICIES AND PROCEDURES

The Tribal Sponsorship Program is offered to aid Tribal members in accessing reimbursement funding to address the following needs; Emergency Preparedness and Energy Generation, Health and Fitness, Healthy Foods, and Technology. Applicants will need to provide copies of receipts with the application verifying the purchase you will be requesting reimbursement for. This program is a limited duration program and will end once the funding has been exhausted. Applications will be process in the order a completed application is received.

### I. APPLICANT ELIGIBILITY REQUIREMENTS

Tribal Sponsorship Program reimbursement may be awarded and applied towards the costs of Emergency Preparedness and Energy Generation, Health and Fitness, Healthy Foods, and Technology

Applicant Eligibility Requirements:

1. The applicant must be an enrolled member of the Confederated Tribes of Grand Ronde;
2. The applicant must provide a copy of Tribal Enrollment Verification from the CTGR Enrollment Office;
3. The applicant must be at least 18 years of age;
4. There are no residency requirements;
5. **Household** is defined as one per physical address;
6. If you owe a debt from any of the COVID-19 programs offered in 2021 you are **NOT** eligible to apply.

### II. PURCHASE(S) ELIGIBLE FOR REIMBURSEMENT:

Household is defined as one per physical address.

#### **Emergency Preparedness and/or Energy Creation**

Tribal household may receive a one-time time reimbursement of up to \$300 towards the costs associated with purchase of Emergency Preparedness and/or Energy Creation supplies include but are not limited to: emergency preparedness kits,

water filtration devise, battery or hand crank radio, extra batteries, non perishable dehydrated foods, flashlights, headlamp, solar charger, solar equipment and supplies, generator, emergency blanket, first aid kit, wool blanket, fire extinguisher, smoke alarm.

### **Healthy Foods**

Tribal household may receive a one-time Healthy Foods Assistance Program reimbursement of up to \$300 towards the costs related to healthy food preparation, preservation and nutrition such as fruit and vegetable starters/seeds, gardening and canning supplies and online meal kits.

### **Health & Fitness**

The Confederated Tribes of Grand Ronde Tribal members may receive a one- time Health & Fitness Assistance reimbursement of up to \$300 towards the costs associated with exercise equipment such as free weights, elliptical, treadmill, and gym membership.

### **Elder Technology** (not eligible if you have already received)

The Confederated Tribes of Grand Ronde Tribal Elder members may receive a one time Technology Program reimbursement of up to \$500 towards the costs of technology required for continues involvement and access to Tribal services, suchas computer, laptop, web camera, internet access fees and the like.

### **Student Technology** (not eligible if you have already received)

Confederated Tribes of Grand Ronde Tribal members enrolled in school, kindergarten through college may receive a one time Technology Program reimbursement of up to \$500 towards the costs of technology required for distance learning, such as computer, laptop, web camera, internet access fees and the like.

### **Non Elder Non Student Technology** (not eligible if you have already received)

The Confederated Tribes of Grand Ronde Tribal members who are Non Elder and Non Student age 3 and above may receive a one time Technology Program reimbursement of up to \$200 towards the costs of technology required for continues involvement and access to Tribal services, such as computer, laptop, web camera, internet access fees and the like.

## **III. TERMS AND CONDITIONS:**

- A. Qualified Tribal member(s) will receive a reimbursement check for the amount of the receipt(s) of purchase up to the maximum limits for each program they are eligible. This is a one time allowance.
- B. The Confederated Tribes of Grand Ronde staff **will not** provide any additional support for items purchased by the applicant. This is the applicant's sole responsibility.

## VII. IMPLEMENTATION AND POLICY REVIEW

This policy shall become effective upon review and approval by the General Manager. The Education Department staff are responsible for the implementation of this policy upon approval. This is a ***limited*** duration program and will be awarded based on the date a completed application is received. Once funding is exhausted the program will end. Any questions regarding the policy or application should be directed to the Education Department Manager.
