## **ADMINISTRATIVE ORDER 24-002**

## POLICY REGARDING AUTHORITY IN THE ABSENSE OF COURT ADMINISTRATOR

GRAND RONDE COMMUNITY OF OREGON

The purpose of this administrative order is to address authority in the absence of the Court Administrator.

WHEREAS, Article IV of the Grand Ronde Constitution vests authority to the Chief Judge to exercise all judicial authority of the Tribe, to include the power to review and overturn tribal legislative and executive actions.

WHEREAS, Tribal Court Ordinance Chapter 302 provides for the administration of law and justice by the Confederated Tribes of Grand Ronde through the establishment of a Tribal Court system as required by Article IV of the Grand Ronde Constitution.

WHEREAS, Tribal Court Ordinance Chapter 302 empowers the court to exercise the judicial authority of the Tribe as delegated herein.

WHEREAS, the Court recognizes the need to designate authority to ensure a smooth and efficient operation of the Court in the absence of the Court Administrator.

The Tribal Court Ordinance Chapter 302, adopted on April 12, 1989 and last amended on October 23, 2013 sets out in section (f), Administration of the Court. The administrative function of the Tribal Court shall be performed by the Court Administrator or designee. The Court Administrator shall be responsible for the management of the office and supervision of the court
