



File your PACT Act claim by August 9, 2023 to be eligible for backdated benefits

Find your nearest accredited Tribal Veterans Service Officer or County Veterans Service Officer. And file a claim or an Intent to File. If you are not prepared to file a full claim before August 9, 2023, file an Intent to File before that date to preserve your filing date and remain eligible for backdated benefits if granted by VA.

Vietnam Veterans - PACT Act Claim - Hypertension Explained

Hypertension Rating Formula Sheet

HOW DISABILITY RATINGS WORK

The VA determines a disability rating after reviewing your service treatment records ("STR"), C&P exam report and any other evidence submitted to them in support of your claim based on the criteria below. You may have one or more symptoms in a higher disability rating, but still receive a lower rating that reflects where MOST of your symptoms are present. If you have multiple injuries, disability ratings are not added together (60%+40%≠100%). The VA has an internal ranking system of injuries that will determine your final disability rating.

RATING FORMULA FOR HYPERTENSION (HIGH BLOOD PRESSURE)

(Hypertensive vascular disease, hypertension and isolated systolic hypertension):

PERCENTAGE	DESCRIPTION
60%	If the average diastolic pressure is 130 or more
40%	If the average diastolic pressure is 120 to 129
20%	If the average diastolic pressure is 110 to 119, or the average systolic pressure is 200 or more
10%	If the average diastolic pressure is 100 to 109, or the average systolic pressure is 160 to 199 or the average diastolic pressure was 100 or more before fully controlled by medication and continuous medication is required to keep the blood pressure under control

- Readings are with blood pressure medications.
- To qualify for a high blood pressure rating, the condition must be clearly documented by the physician. Blood pressure readings must be taken two or more times a day on at least three different days in order for the condition to be officially diagnosed. A blood pressure log of 2 or more readings over 3 or more days qualifies as lay evidence even if not done by a physician.
- Your Primary Care Physician can give you a home blood pressure machine if requested.
- A rating under this code cannot be combined with a rating for the underlying condition that caused the high blood pressure. Only the code that allows for the highest rating can be used for the condition such as renal dysfunction (kidney disease).
- A rating for high blood pressure can, however, be used in addition to ratings for hypertensive heart disease and other heart diseases.

Even a 0% service connected non-compensable rating is important if the Veteran were to pass away from a heart condition for survivor benefits (Dependent Indemnity Compensation) if the cause of death listed on the death certificate indicates or in a doctor's letter that service connected hypertension is at least as likely as not (50% chance or greater) a contributing factor in the death.

If you were granted for Hypertension at 0%, you are now considered service-connected for Hypertension; just at a non-compensable percentage (no pay).

If your rating came back at 0% and you feel it should be higher, speak with your physician.

Show your physician the Rating Formula Sheet and speak with them about your blood pressure. The provider can help you figure out what your blood pressure numbers are.

Your medical documentation needs to show that your condition meets the criteria on the rating sheet. We can submit that to VA as new evidence to request a rating higher than 0%.

(Remember, there is no guarantee that VA will rate you higher).

PACT Act - What Are Toxics?

The PACT Act stands for: Sergeant First Class Heath Robinson Honoring Our Promise to Address Comprehensive **Toxics** (PACT) Act of 2022. This legislation encompasses **toxics** of all types (see list below). Keep this in mind when deciding whether to file a claim:

Below are examples of toxics to which servicemembers may have been exposed during service:

- Chemicals (Herbicides, pesticides, industrial solvents)
- Radiation (nuclear weapons, depleted uranium)
- Air pollutants (burn pit smoke, particulate matter)
- Occupational hazards (asbestos, lead, paint, fuels)
- Warfare agents (mustard gas, nerve agents, biological weapons)
- Other garrison exposures (per- and poly-fluoroalkyl substances, volatile organic compounds, solvents, paints, fuels)

If you believe you were exposed to toxins in service but;

- ◇ You did not serve in one of the presumptive locations previously shown, and / or
- ◇ You did not serve during one of the time periods shown, and / or
- ◇ You have a disability related to exposure, but it's not one of the presumptive disabilities previously shown... 

**If you aren't
sure, file a
claim anyway!**

Filing A Successful Regular Claim for VA Benefits

To file a successful claim, you need **three** things:

- 1) A current, diagnosed disability and
- 2) An in-service event, injury, or illness; and
- 3) A medical nexus between the current disability and the in-service event, injury, or illness (a link between 1 and 2).

Documents Needed to Prove Your Claim:

- 1) Your medical diagnosis, information, and records
- 2) Your military medical records if you have them
- 3) Any and all documentation that could help support your claim

Filing a Claim for Presumptive Conditions

Ask yourself the following questions

(refer to p. 8 or 9) :

- Have I served in any of the identified **presumptive locations**? **And,**
- Have I served during the identified **presumptive time periods** for that location? **And,**
- Am I diagnosed with a **chronic illness** from the presumptive lists ?

Bring the evidence you have to show proof of these three elements to your claim appointment.

If you do not have all the needed documents, you can also submit an “Intent to File” Form by setting up an appointment with me. Or, call 1-800-827-1000. This will preserve your filing date for up to a year while you gather your documents.

Are you ready to file your claim?

If so, you can file multiple ways:

- ⇒ Set up an appointment with me or an accredited representative in your state
- ⇒ Gather all of the items from the “Documents Needed” (on p.6) or,
- ⇒ Go online and file through your VA.Gov Online Account or,
- ⇒ By Mail or,
- ⇒ Drop off your application and documents at the nearest Regional Office (check in your state).

Beneficiary Travel

From Beneficiary Travel: the 30-Day Timely Filing Rule is coming back into effect on Friday, June 9, 2023, meaning eligible Veterans will have 30 days to file their travel claim for reimbursement after an appointment that meets the criteria. Annual Clothing Allowance

Clothing Allowance - VA Form 10-8678—Must submit before August 1st!!

Has your clothing been damaged by your prosthetic or orthopedic device (such as a wheelchair) or by the medicine you're taking for a skin condition? If it has, you may be able to get money each year to help you buy new clothes. This is a disability compensation benefit known as an annual clothing allowance. Find out if you can get this benefit.

Introduction

Military service members can receive expedited processing of disability claims from Social Security. Benefits available through us are different from those available through the Department of Veterans Affairs and require a separate application.

The expedited process is used for military service members whose disability occurred while on active military duty on or after October 1, 2001, regardless of where the disability occurs.

What is Social Security's definition of disability?

By law, we have a very strict definition of disability:

- You must be unable to do substantial work because of your medical condition(s).
- Your medical condition(s) must have lasted, or be expected to last, at least 1 year or to result in death.

While some programs give money to people with partial disability or short-term disability, we do not.

Disability Benefits for Wounded Warriors

Did you know that *100% service-connected total and permanent disabled veterans can submit a copy of their letter stating their disability to Social Security when they apply? This letter will be used as evidence to support your request for Social Security benefits and may potentially expedite your request.

*(*Being 100% service-connected total and permanently disabled doesn't guarantee approval of Social Security benefits).*


